## General Policy on Copying Records

The Archives of the Kodiak Historical Society were created, and are administered, in order to collect, preserve, and make available for research use papers, photographs and other records relating to the history of the Kodiak and Aleutian Islands area. Limitations on copying/reproducing some records are dictated by law (privacy, copyright, etc.), organizational policy, and/or the condition of the records.

Unrestricted records are open to general use and copying. Records will not be loaned for copying, and all copying will be done by Kodiak Historical Society staff. Reasonable fees for copying based on a published scale will be uniformly imposed (please consult current fee schedule). Fees must be paid at the time the order is placed. Permission for researchers to use their own equipment in copying will generally be denied. Permission to copy photographs from deposited collections or from those collections for which the institution or public does not own the copyright must be obtained in writing from the depositor or copyright owner; otherwise, only xerographic copies will be provided. Generally, copies made under "fair use" provisions of the copyright law will be xerographic copies. In cases in which the ownership or copyright holder, or their heirs, are not known or available, the researcher will be required to sign a release when copies are provided.

The researcher must agree to hold harmless the Kodiak Historical Society and all officers, members, and staff, for any violations of copyright or other rights associated with the copying or use of the materials by the researcher.

The copying of materials from the Kodiak Historical Society collections is for a one-time use only. Copies are solely for the use of the researcher for whom they were made. Any further reproduction without the specific written approval of the Kodiak Historical Society is prohibited. Copies made for researchers are not to be deposited in any other archives, manuscripts repository, or library.

Those wishing to publish copied material must submit the requisite paperwork and fee to do so. Please see the Kodiak Historical Society, Archives & Manuscripts **Application for Permission & Project Description** and **Fee Schedule**.

**PAYMENT:** Fees are expected at the time of the order. Please make checks payable to the Kodiak Historical Society. Fees are subject to change without notice.

**TIME FRAME:** The Kodiak Historical Society will attempt to complete copying projects within a reasonable period of time. A minimum of two full work weeks should be allowed for copying projects. Large projects and those requiring prior approval by the copyright holder (which must be in writing) take more time. The completion of a project is dependant on the number of other orders, the length of the project, and the availability of staff. The Kodiak Historical Society is not staffed or equipped to handle rush photograph copying orders. When there is an extraordinary demand for a rush project, a special fee (to be paid in advance) will be imposed.
