The Articles of Agreement were signed October 1, 1927, by Simeon Agnot, Lezon Alokli, Mike Farsovitch, Goverilla Azuyak, Willie Eluska, Ivan Constantine, Eluska Androvitch and Peter Alevedoff.

The reindeer was valued at \$25.00 per head and \$1.00 per share.
